They often have to meet higher standards of conduct in relation to their organisations and the wider society. They also need to practice effective governance to manage their performance and the organisations they serve.

It aims to help them advance their fiduciary, legal and ethical oversight responsibilities. ## Programme Details

# Governance and the Practice of Directorship

Board Directors will develop a practical understanding of the principles underlying a sound corporate governance system and the special considerations in relation to stewarding state-owned institutions. Participants will explore the roles played by the state, boards, directors, executive management, and other stakeholders within the broader corporate governance environment.

#### **Emotional Intelligence in the Boardroom**

This course moves beyond the basics of emotional intelligence to concentrate on using it to build trust to promote long-term and sustainable value creation. It recognises that emotionally intelligent board directors help their organisations set a positive culture and excel even in uncertain times. Through assessments, reflective exercises and discussions, directors become more aware of their own behaviours as well as how that impacts their leadership styles and others.

# Strategic Management of Public Resources

The board's financial oversight is required to ensure economic and resource stewardship that leads to better performance and outcomes for the public. This session is oriented towards understanding the principles and guidelines of effective use of public resources, procurement of goods and services, and audit issues. Board directors will be informed of their direct involvement in ensuring integrity and efficiency in managing SOIs resources.

## Risk Management and Internal Controls Fundamentals

It is the board's responsibility to ensure that risks to the delivery of a strategy are effectively managed. This course aims to inform board directors on key risk management concepts and enhance their competencies in carrying out oversight roles. It puts an emphasis on their ability to set a positive ethical tone and influence the control environment in SOIs.

### **Achieving Board Effectiveness**

During this course, directors will understand the performance contract tools used by the Office of the Treasury Registrar (TR). In essence, these contracts allow them to measure the performance of their SOI against agreed targets with the TR.
